- Through the [Transition to Organic Partnership Program \(TOPP\)](#) the USDA is investing up to \$100 million over five years in cooperative agreements with non-profit organizations to increase the number of farmers transitioning to certified organic production.
- FARRMS is part of the [Plains Transition to Organic Partnership Program \(Plains TOPP\)](#). Led by [OCIA International](#), Plains TOPP is a coalition of organizations providing technical assistance and wrap-around support for transitioning and existing organic farmers. Plains TOPP serves operators in Colorado, Kansas, Nebraska, North and South Dakota, and Oklahoma.
